stipulate the following certification agreement, which encompasses the following obligations and rights for the Client and for AUVA-STP:

**Object of Certification:**

Herewith the client obligates himself to comply with the following points:

- 1. The client agrees to the terms and conditions and the certification program.
- 2. The client always fulfils the certification requirements, including implemented changes. Certification requirements are product requirements according to normative documents but also requirements that are not product requirements.
- 3. During the production process, the certified product fulfils permanently the demanded requirements.

- 4. In order to fulfill the (if required) surveillance in accordance with Annex VII (Module C2) or Annex VIII (Module D) of PPE Regulation (EU) 2016/425, the personnel of AUVA-STP is entitled to execute unannounced visits of the factory and its premises in order to carry out necessary monitoring activities. Furthermore, the client has to make possible eventual witness audits by the accreditation body or surveillance activities of the inspector carried out by the head of the inspection body.
- 5. The client complies with the requirements of the applicable certification scheme PPE and the respective standards.
- 6. The client does not use the product certification a way which could be discreditable for the certification body. When published in communication media (brochures or advertising) the client complies with the requirements of the certification body or as specified by the certification scheme.
- 7. Upon suspension, withdrawal, or termination of certification, the client discontinues its use in all advertising material containing any reference thereto (see also General terms and conditions).
- 8. If certification documents are made available to third parties, they must be reproduced in their entirety or as specified in the certification scheme.
- 9. When referring to its certification in communication media, the client undertakes to fulfil the requirements of the body or the certification programme
- 10. The client complies with any requirements relating to the use of marks of conformity, and on information related to the product.
- 11. The client keeps records of all complaints made known to him, relating to compliance with certification requirements, and makes these records available to the certification body when requested. The client takes appropriate action and documents the actions taken.
- 12. The client complies to inform AUVA-STP immediately of any changes that could affect the fulfilment of the certification requirements. AUVA-STP alone decides whether a re-examination within the scope of the initial examination is necessary.

In case of judicial proceedings, the place of jurisdiction shall be Vienna. This agreement is subject to Austrian law. The General terms and conditions apply.
